

Brighton Square Improvement Association
Pool, Barbecue Area and Common Area Reservation Agreement

I am a member in good standing of Brighton Square Improvement Association (BSIA) or have been authorized by the owner of my home who is a BSIA member in good standing to use the facilities. I am interested in hosting a party at the BSIA facility. Please read and sign this form as acknowledgement of the terms of this agreement. We want everyone to have fun but also to be considerate of others in our community

- General
- I understand that I must make a reservation for the following events:
- A BBQ party in the BBQ area or
- **A poolside party larger than 8 person or**
- To install party equipment in the common area (the park or parking lot) Proof of insurance may be required
- I will be present the entire time that my party is using the BSIA facility. I will not substitute another BSIA member to host my party.
- I agree that I will have the party area cleaned up and that I will leave by the end of my reservation period.
- When I leave, all of my guests will leave.
- I will not make reservations for anyone other than myself
- I understand that since the Association levies only a minimal charge to Members for use of the facility, it will not compensate me in the event of a staffing error.
- If I bring my own barbecue, I will obey the same rules (ie. I will only use the barbecue area and the 2 tables closest to the barbecue area.
- **PARTY SIZE**
- If I host a private party during a time when the pool is not open to all members, the party size will be limited to 100 pool users, excluding chaperones
- If I host a private party during a time when the pool is open to all members, the party size will be limited to a total of 75 participants.
- **ENFORCING the BSIA COMMON AREA RULES**
- My guests and I will abide by all of the Common Area Rules in effect at the time of the party. (Copies of the rules are mailed to all members at the beginning of the season).
- Upon arriving at the facility, I will introduce myself to the head lifeguard (stationed closest to the lifeguard office)
- If a duty lifeguard asks me to help enforce the rules and/or control my guests, I will immediately comply.
- If I am asked to provide a full-time chaperone at the poolside, I will do so
- **NOISE from BOOM BOXES and DJs**
- If I use a boom box or DJ to entertain my guests, I will be considerate of the pool neighbors.
- I will instruct the DJ to turn the bass down to minimize vibration.
- **RESERVATION TIMES**
- The reservation person will allow 1 hour between scheduled BBQ Parties. I agree that if my party is not the first party of the day, I will appear in the BBQ area to set up for my party at most one (1) hour before my confirmed reservation.
- **FEES**
Pool parties are now \$60 for 4 hours and \$15 an hour for each additional hour while pool is open. 12-4pm or 4-8pm.
School parties are: 50 people and under is \$150 an hour.
51 people up to 125 people (max) is \$250 an hour.
Parties booked at 50 or less people will have two lifeguards. For every 25 more people attending another lifeguard shall be added.

I understand that if I do not abide by these rules set forth in this Agreement, I may (1) be asked to leave the facility and (2) lost my privilege to make future pool and barbecue reservations.
